Synergy Operating, LLC, Edwin Smith, LLC, and Jerry Walmsley, Trustee jointly file this stipulation.


I. STIPULATION FOR A CONTINUANCE.

II. STIPULATION FOR STAY.

As part of the stay, Synergy Operating, LLC will not commence drilling its Duff 29-11-8 Well No. 104, to be located in the NW¼ of Section 8, Township 29 North, Range 11 West, NMPM, until the stay expires or is dissolved. **BY THE DIVISION:**

**THIS MATTER** came before the Director of the Oil Conservation Division (the Division) for consideration on September 29, 2005 at Santa Fe, New Mexico on the joint application of Synergy Operating, LLC, Edwin L. Smith LLC and Jerry Walmsley, Trustee for a stay of Division Order No. R-12376, and the Director, having reviewed the matter and carefully considered the same, now, on this 3<sup>rd</sup> day of October, 2005,

**FINDS THAT:**

All parties in interest have agreed to the requested stay, and it should therefore be granted.

**IT IS THEREFORE ORDERED THAT:**

- (1) Order No. R-12376 is hereby stayed until December 1, 2005.
- (2) ~~Synergy Operating, LLC shall not commence drilling its Duff 29-11-8~~  
Well No. 104, to be located in the Northwest Quarter of Section 8, Township 29 North, Range 11 West, NMPM, until this order expires or is dissolved.
- (3) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
