## JOINT MOTION FOR CONTINUANCE

Edwin Smith, LLC, a New Mexico limited liability company, (Edwin Smith, member-manager) ("Smith"), and Jerry Walmsley, Trustee, Bypass Trust U/W June H. Walmsley, (Walmsley) request that the New Mexico Oil Conservation Commission (the Commission) grant a continuance of the *de novo* hearing of Division Order No. R-12376 scheduled for August 18, 2005 until the Commission's September, 2005 docket for the following reasons:

- Earnest Smith, member of Edwin Smith, LLC, and part-owner of the subject mineral interests will be unable to attend the hearing because he was diagnosed with a terminal illness late last week and has been hospitalized as a result of the illness.
- Edwin Smith, member/manager of Edwin Smith, LLC, and part-owner of the subject mineral interests will be unable to attend the hearing because he is helping care for his father, Earnest Smith. See Affidavit of Edwin Smith, attached and incorporated herein as Exhibit 1.
- 3. At the June 16, 2005, hearing in this matter before the OCD Hearing Examiner, Synergy promised it would provide the parties with a title opinion for the subject property. Synergy, through its counsel James Bruce, has informed the parties that due to increased drilling activity in the area in which

the subject property is located, professional title services have been delayed.

A continuance would give Synergy time to obtain and distribute the title opinion it promised the parties at the hearing.

- 4. A continuance until the September docket may also afford Synergy time for the BLM to process its application to drill and subsequently to obtain a permit to drill the subject well.
- Synergy does not object to a continuance of the *de novo* hearing of Division
   Order No. R-12376 scheduled for August 18, 2005 until the Commission's
   September 2005 docket.

For the foregoing reasons, Smith and Walmsley respectfully request that the Commission grant a continuance of the *de novo* hearing of Division Order No. R-12376 scheduled for August 18, 2005 until the Commission's September, 2005 docket.
