Applicant Matador Production Company seeks an order approving an unorthodox well location for its [Tiger 14, 24S-28E RB #227H] to be drilled horizontally to the Wolfcamp formation for the production of gas from the Culebra Bluff, Wolfcamp South Gas pool. The

Applicant proposes to complete the well as close as 330' from the boundaries of the project area for the well. The Tiger 14, 24S-28E RB #227H is to be located in the S/2 of Section 14, Township 24 South, Range 28 East, NMPM in Eddy County.


