RKI Exploration and Production ("RKI") seeks an order (1) creating a 160-acre, more or less, non-standard spacing and proration unit comprised of the E/2 E/2 of Section 17, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Wolfcamp formation. Said non-standard unit is to be dedicated to applicant's proposed **RDX Federal Com 17 No. 40H Well**, which will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) to a standard bottom hole location in in the SE/4 SE/4 (Unit P) of Section 17. The completed interval for this well will comply with the Division's setback requirements.
