APPLICANT'S STATEMENT OF CASE

COG Operating LLC ("COG") seeks to amend Order No. R-14033 to contract the approved 640-acre non-standard project area to 480-acres comprised of the W/2 and W/2 E/2 of Section 27, Township 21 South, Range 33 East, NMPM Lea County, New Mexico. COG has drilled three wells in Section 27: The Pygmy 27 State 1H (API 30-025-403523), currently dedicated to the W/2 W/2 of Section 27; the Pygmy 27 State 2H (API 30-025-42062), currently dedicated to the E/2 W/2 of Section 27; and the Pygmy 27 State 3H (API 30-025-42068), currently dedicated to the W/2 E/2 of Section 27. COG initially planned to drill the Pygmy 27 State 4H (API 30-025-42069) in the E/2 E/2 of Section 27 but has now determined the better

course is to combine this acreage with the E/2 E/2 of Section 22 to the North to drill a two-mile lateral well. COG has conferred with the New Mexico State Land Office and it has indicated it will approve a 480-acre Communitization Agreement covering the Bone Spring formation underlying the W/2 and W/2 E/2 of Section 27 to allow the surface facilities for the existing wells to be consolidated. However for administrative purposes the wells drilled in Section 27 must first be dedicated to the subject acreage, which cannot occur without approval from the Division to treat this acreage as a single project area.

Notice of this application has been provided to the affected parties in the 40-acre spacing units that adjoin the proposed 480-acre project area.
