APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks to amend Order R-13963 to pool additional uncommitted interest owners in the non-standard spacing and proration unit. Division Order R-13963, entered on March 2, 2015, created a 200-acre non-standard spacing and proration unit comprised of the W/2 W/2 of Section 11 and the NW/4 NW/4 of Section 14, Township 17 South, Range 32 East, NMPM in Lea County, New Mexico (the "Unit"), and pooled the mineral interests underlying said unit in West Maljamar-Yeso Pool (44500)). The Unit was dedicated to the Pan Head Fee Well No. 12H (API No. 30-025-40899), which was drilled from a surface location from a

surface location 330 feet from the North line and 990 feet from the West line (Unit D) of Section 11, to a standard bottomhole location 966 feet from the North line and 966 feet from the West line (Unit D) of Section 14.. Since the entry of Order R-13963, COG has discovered additional mineral interest owners, primarily in the form of estates with unmarketable title. COG now seeks to amend Order R-13963 to include these additional interests under the terms of the existing pooling order.
