APPLICANT'S STATEMENT OF CASE

Matador Production Company seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the E/2 E/2 of Section 32, Township 18 South, Range 33 East, NMPM, Lea County, New Mexico (the "Unit"); and (2) pooling all uncommitted working interests in the Bone Spring formation. The Unit will be the project area for the proposed **Eland 32-18S-33E RN No. State Com 124H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) to a

standard bottom hole location in the NE/4 NE/4 (Unit A) of Section 32. This project area is located within the Corbin; Bone Spring, South Pool (13160), and the completed interval will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.


