APPLICATION OF RKI EXPLORATION & PRODUCTION, LLC FOR COMPULSORY POOLING AND APPROVAL OF AN UNORTHODOX WELL LOCATION, EDDY COUNTY, NEW MEXICO

# **ORDER OF THE DIVISION**

#### **BY THE DIVISION:**

This case came on for hearing at 8:15 a.m. on July 21, 2016, at Santa Fe, New Mexico before Examiner Michael A. McMillan, and again on August 4, 2016 before Examiner William V. Jones.

NOW, on this 22<sup>nd</sup> day of August, 2016, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

#### FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
- (2) RKI Exploration & Production, LLC ("Applicant" or "RKI"), seeks an order pooling all uncommitted interests in the Wolfcamp formation, Ross Draw; Wolfcamp Gas pool (pool code 84330), underlying the W/2 of Section 17, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico, to form a standard 320-acre gas spacing and proration unit (the "Unit").
- (3) The Unit will be dedicated to the Applicant's RDX Federal 17 Well No. 35H (the "proposed well"; API No. 30-015-43884), a horizontal well to be drilled from a surface location 150 feet from the North line and 895 feet from the West line (Unit D) of Section 17 to a terminus or bottomhole location 230 feet from the South line and 330 feet from the West line (Unit M) of Section 17. The completed interval of the proposed well in the Wolfcamp formation will be unorthodox.

- (4) The proposed well is within the Ross Draw; Wolfcamp Gas pool (pool code 84330), which is governed by statewide Rule 19.15.15.10B. NMAC, and provides for 320-acre gas spacing units with wells to be located no closer than 660 feet from a unit outer boundary.
- (5) Applicant appeared at the hearing through counsel and presented evidence to the effect that:
  - (a) The Wolfcamp formation in this area is suitable for development by horizontal drilling;
  - (b) the proposed orientation of the horizontal well from South to North or North to South is appropriate for the proposed Unit;
  - (c) Applicant seeks a non-standard location for the proposed well. The penetration point is 330 feet from the North line and 330 feet from the West line (Unit D), and the final perforation is 330 feet from the South line and 330 feet from the West line (Unit M);
  - (d) Applicant is seeking the non-standard location to minimize waste of resources and protect correlative rights of their interest holders.
  - (e) the fluid characteristics in the Wolfcamp formation in this pool are 51 API gravity, and the producing GOR is 9000-10000 SCF/ per barrel of oil;
  - (f) notice was provided to all interest owners subject to pooling proceedings as affected parties of the proposed compulsory pooling within the Unit;
  - (g) notice was provided for formation of the spacing unit and nonstandard location to lessees or operators of surrounding tracts; and
  - (h) Applicant provided notice of this application by publication before hearing in a newspaper of general circulation in Eddy County, New Mexico, the county in which the property is located for the unlocatable interests.
- (6) No other party appeared at the hearing, or otherwise opposed the granting of this application.

## The Division concludes that:

(7) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.

- (8) Applicant is owner of an oil and gas working interest within the Unit. Applicant has the right to drill and proposes to drill the proposed well to a common source of supply within the Unit at the proposed location.
- (9) There are interest owners in the Unit that have not agreed to pool their interests.
- (10) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.
- (11) RKI Exploration & Production, LLC should be designated the operator of the proposed well and the Unit.
- (12) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus an additional 200% thereof as a reasonable charge for the risk involved in drilling the proposed well.
- (13) Reasonable charges for supervision (combined fixed rates) should be fixed at \$7,500 per month while drilling and \$750 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations."

## IT IS THEREFORE ORDERED THAT:

- (1) Pursuant to the application of RKI Exploration & Production, LLC all uncommitted interests, whatever they may be, in the oil and gas in the Wolfcamp formation, Ross Draw; Wolfcamp Gas pool (pool code 84330), underlying the W/2 of Section 17, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico (the "Unit"), are hereby pooled.
- (2) The Unit shall be dedicated to the Applicant's RDX Federal 17 Well No. 35H (the "proposed well"; API No. 30-015-43884), a horizontal well to be drilled from a surface location 150 feet from the North line and 895 feet from the West line (Unit D) of Section 17 to a terminus or bottomhole location 230 feet from the South line and 330 feet from the West line (Unit M) of Section 17. The completed interval of the proposed well is authorized to be located at an unorthodox location, the penetration point being 330 feet from the North line and 330 feet from the West line (Unit D) of Section 17, and the final perforation being 330 feet from the South line and 330 feet from the West line (Unit M) of Section 17.

- (3) The operator of the Unit shall commence drilling the proposed well on or before July 31, 2017, and shall thereafter continue drilling the proposed well with due diligence to test the Wolfcamp formation.
- (4) In the event the operator does not commence drilling the proposed well on or before July 31, 2017, Ordering Paragraph (1) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause demonstrated by satisfactory evidence.
- (5) Should the proposed well not be drilled and completed within 120 days after commencement thereof, then Ordering Paragraph (1) shall be of no further effect, and the unit and project area created by this order shall terminate, unless operator appears before the Division Director and obtains an extension of the time for completion of the proposed well for good cause shown by satisfactory evidence.
- (6) Upon final plugging and abandonment of the proposed well and any other well drilled on that Unit pursuant to Division Rule 19.15.13.9 NMAC, the Unit created by this Order shall terminate, unless this Order has been amended to authorize further operations.
- (7) RKI Exploration & Production, LLC (OGRID 246289) is hereby designated the operator of the well and the Unit.
- (8) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping the proposed well ("well costs").
- (9) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."
- (10) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected, within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within

the 45-day period, the Division will determine reasonable well costs after public notice and hearing.

- (11) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.
- (12) The operator is hereby authorized to withhold the following costs and charges from production from each well:
  - (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and
  - (b) as a charge for the risk involved in drilling the well, 200% of the above costs.
- (13) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.
- (14) Reasonable charges for supervision (combined fixed rates) for the well are hereby fixed at \$7,500 per month while drilling and \$750 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.
- (15) Except as provided in Paragraphs (12) and (14) above, all proceeds from production from the proposed well that are not disbursed for any reason shall be held for the account of the person or persons entitled thereto pursuant to the Oil and Gas Proceeds Payment Act (NMSA 1978 Sections 70-10-1 through 70-10-6, as amended). If not disbursed, such proceeds shall be turned over to the appropriate authority as and when required by the Uniform Unclaimed Property Act (NMSA 1978 Sections 7-8A-1 through 70-8A7-8A-31, as amended).
- (16) Any unleased mineral interests shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.

- (17) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this Order, this Order shall thereafter be of no further effect.
- (18) The operator of the well and Unit shall notify the Division in writing of the subsequent voluntary agreement of parties subject to the compulsory pooling provisions of this Order.
- (19) Jurisdiction of this case is retained for the entry of such further Orders as the Division may deem necessary.
