2 EXAMINER JONES: I have case 15281. I call
3 that one, Application of COG Operating LLC for a
4 non-standard spacing and proration unit and compulsory
5 pooling, Eddy County, New Mexico.

6 Call for appearances.

7 MR. FELDEWERT: May it please, Examiner,
8 Michael Feldewert with the Santa Fe office of Holland
9 and Hart. And I have no witnesses. And I have two
10 additional exhibits.

11 EXAMINER JONES: Okay. No other
12 appearances?

13 (No response.)

14 MR. FELDEWERT: Mr. Examiner, this matter
15 was heard on by the Division on the April 2nd docket.
16 At that time, COG presented two witnesses simply to pool
17 the Yeso formation from the surface down to 3,200 feet.
18 We offered ten exhibits at that time.

19 And it was continued first because Mr. Wade
20 noted the newspaper had failed to publish notice of the
21 hearing in a timely fashion, so we needed to continue
22 for a period of time to allow that notice to occur.
23 And, secondly, it was continued to allow notice to the
24 owners in the portion of the pool that are not included
25 in the pooled interval.

1 That has now been accomplished with the two
2 Exhibits that I presented to you here today, COG Exhibit
3 11, continuing on with the exhibit number sequence.
4 Exhibit 11 is a notice of publication in a newspaper of
5 this hearing and the pool interval, providing notice to
6 those interest owners in the pool that we were unable to
7 locate.

8 And then COG Exhibit 12 is my affidavit with
9 the attached letter providing notice to the owners
10 within the pool that we were able to locate that are not
11 being included in the pooling application.

12 So with these additional notice exhibits No.
13 10 and 11, this matter is ready to be taken under
14 advisement. So we ask that COG Exhibits 11 and 12 be
15 admitted.

16 EXAMINER JONES: Exhibits 11 and 12 are
17 admitted.

18 (Whereupon, COG OPERATING LLC Exhibits 11
19 and 12 were offered and admitted.)

20 MR. FELDEWERT: And that concludes our
21 presentation. And we ask that the case be taken under
22 advisement.

23 EXAMINER WADE: No questions.

24 EXAMINER JONES: Thank you very much.

25 And we will take case 15281 under

1 advisement.

2 MR. FELDEWERT: Thank you.


