APPLICANT'S STATEMENT OF CASE

In these two cases, Matador Production Company seeks an order pooling all uncommitted interests in the Wolfcamp formation for two standard 320-acre spacing and proration unit comprised of the E/2 of Section 25 and the W/2 of Section 25, Township 23 South, Range 27 East, NMPM, Eddy County, New Mexico.

The E/2 spacing unit will be the project area for the proposed **Warren 25-23S-27E RB No. 203H Well**, which will be horizontally drilled from a surface location in

the SW/4 SE/4 (Unit O) to a standard bottom hole location in the NW/4 NE/4 (Unit B) of Section 25, Township 23 South, Range 27 East.

The W/2 spacing unit will be the project area for the proposed **Warren 25-23S-27E RB Fed Com No. 206H Well**, which will be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) to a standard bottom hole location in the NE/4 NW/4 (Unit C) of Section 25, Township 23 South, Range 27 East.

The project areas in the E/2 and W/2 of Section 25 are both located within the Black River; Wolfcamp, East (Gas) Pool (97442) and governed by the Special Rules as adopted by Division Order R-14185. Rule 3 of the Special Rules for the Black River; Wolfcamp, East (Gas) Pool requires that the well be located no closer than 330 feet to the outer boundary of the project area. The completed interval for each of the proposed wells will remain within the 330-foot offset required by the Special Rules for the Black River; Wolfcamp, East (Gas) Pool.
