In connection with the above, please note the following:

The estimated cost of drilling, testing, completing, and equipping the Well is \$7,709,873 as itemized on the enclosed Authority for Expenditure (“AFE”) dated June 1, 2016.

The proposed surface location of the Well is approximately 1796’ FNL and 356’ FEL of Section 14, Township 24 South, Range 28 East, Eddy County, New Mexico. The proposed bottom hole location of the subject well is approximately 1678’ FNL and 240’ FWL of Section 14, Township 24 South, Range 28 East, Eddy County, New Mexico.
