
Gentlemen:

On August 11, 2016 OGX Operating LLC ("OGX") sent your company a letter proposing the captioned well. Since that time OGX has realized that the bottom hole location in the letter should have stated 330' FNL and 2,411' FWL instead of 2,411' FEL( which was correctly stated in the AFE), and OGX has also moved the bottom hole location from 2,411' FWL to 2,310' FWL of said Section 28. In addition, since we moved the kick off point to 2,310' FWL and 50' FSL of said Section 33 we will be drilling approximately 810' Southwest, then drilling North approximately 280' to the penetration point which will be approximately 2,310' FWL and 330' FSL of said Section 33. We will then turn horizontal with an azimuth of 359.23 degrees for a total horizontal distance of approximately 6,981' to test the Wolfcamp formation. The total measured depth is estimated to be 16,981'. Enclosed is the C-102 which denotes the changes.

The remaining content of our August 11, 2106 letter remains the same with the exception of the information above.

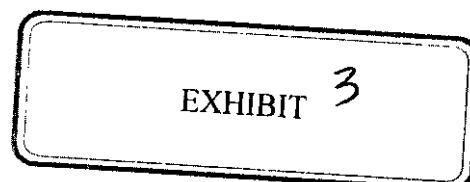
