2 EXAMINER JONES: Let's do the prehearing  
3 transcript right now by going over the docket and list  
4 continuances and dismissals.

5 On the first page, Case Number 15582 is  
6 continued to January the 5th. Case Number 15589 is  
7 continued to January the 5th. That's January 5th of  
8 2017.

9 On page 2, we've already continued Case  
10 Number 15590 to December the 15th. Case Number 15547 is  
11 continued to January the 5th. Case 15548 is continued  
12 to January the 5th; 15549 to January the 5th; 15550 to  
13 January the 5th; 15551 to January the 5th.

14 On page 3, Case 15552 continued to January  
15 the 5th. Case 15562 continued to January the 5th.

16 On page 4, Case Number 1556 -- I'm sorry --  
17 15600, 15601 and 15602 are all continued to December the  
18 15th.

24 And on page 7, Case 15581 is continued to  
25 December the 15th. Case 15585 is dismissed. And Case

1 15594 is continued to January the 5th of 2017.

2 Are there any other changes or continuances  
3 or dismissals to the docket?

4 MR. HERRMANN: Mr. Examiner, did I hear you  
5 say something about 15590, that case we just heard?

6 EXAMINER JONES: Yes.

7 MR. HERRMANN: Continued to December 15th?

8 EXAMINER JONES: Yes.

9 MR. HERRMANN: Okay.

10 EXAMINER JONES: Okay. We've got two or


