### **APPLICANT'S STATEMENT OF THE CASE**

In Case No. 15594, BC seeks an order (1) creating a 160-acre, more or less, non-standard spacing and proration unit comprised of the SE/4 of Section 25, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interest owners in the Wolfcamp formation (WC; Salt Draw; Wolfcamp (G) Pool (Pool Code 97721)) underlying the E/2 of Section 36 and the proposed non-standard spacing and proration unit comprised of the SE/4 of Section 25 to form a 480-acre non-standard spacing and proration unit for the proposed horizontal well. The 480-acre non-standard spacing and proration unit will be the project area for the proposed **Southern Comfort 25-36 State Com X #2H Well**, which will be drilled horizontally from the NE/4 SE/4 (Unit I) of Section 25 to a non-standard bottomhole location in the SE/4 SE/4 (Unit P) of Section 36. Applicant will apply administratively for an unorthodox location for this well.
