STATEMENT OF THE CASE

Applicant Cimarex Energy Co. seeks an order (1) creating a non-standard 360-acre, more or less, oil spacing and proration unit in the bone Spring formation, comprised of the N/2 N/2 of Sections 26 and 27 and the NE/4 NE/4 of Section 28, Township 19 South, Range 30 East, NMPPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this proposed non-standard project area and spacing and proration unit.

Devon Energy Production Company has agreed to participate in Cimarex's proposed well. The parties are awaiting finalization of their agreement, and therefore this Pre-Hearing Statement is provisional. Devon reserves the right to participate in the hearing and present witness testimony.
