In reference to the approval letter dated May 25, 2016 for the Betonnie Tsosie Unit Agreement, Rio Arriba and San Juan County, New Mexico. Please note the corrected effective date of October 1, 2014. The Unit Agreement was approved May 25, 2016 and effective October 1, 2014. This agreement has been assigned case recordation number NMNM135219X. The basic information associated with this unit is as follows:

1. This is an Undivided Unit and only the Mancos Formation is unitized.
2. This unit includes Federal and Indian Allotted mineral estates.
3. The leases committed to the Betonnie Tsosie Unit will not be horizontally segregated.
4. The Lybrook H04-2208 #01H well is the initial obligation well. The Lybrook H04-2208 #01H surface hole location is located in the S/2N/2, Section 4, T.22 N., R.8 W., San Juan County, New Mexico. The well name for Lybrook H04-2208 #01H needs to be changed to the Betonnie Tsosie Unit well name.
5. The following Federal leases contain lands both inside and outside the Betonnie Tsosie Unit and are subject to segregation provisions pursuant to 43 CFR 3107.3-2, Segregation of leases committed in part:
 - a. NMNM 048989 Held By Actual Production
 - b. NMNM 50999 Held By Actual Production
 - c. NMNM 76842 Held By Actual Production
 - d. NMNM 81638 Held By Actual Production
 - e. NMNM 118132 Held By Actual Production
6. The Betonnie Tsosie Unit embraces unleased lands as noted on Exhibit B, 160.00 acres on Tract 16, SW/4, Sec. 33, T.23 N., R.8 W. and 160 acres on Tract 17, SW/4, Sec. 5, T.22 N., R.8 W.

The Betonnie Tsosie Unit embraces 13,137.00 acres more or less, of which 10,900.89 acres are federal mineral estate (82.9785%) and 2,236.11 acres are Indian Allotted lands (17.0215%). All lands embraced within the Betonnie Tsosie Unit are fully committed.

In view of the foregoing commitment status, effective control of the unit area has been established. We are of the opinion that this agreement is in the public interest and for the purpose of more properly conserving natural resources.

In accordance with Article 9 of the Unit Agreement Lybrook H04-2208 #01H has been drilled, completed on December 7, 2014. The public interest requirement for the Betonnie Tsosie Unit agreement has been satisfied. Pursuant to the subsequent drilling obligations of Section 10 of the unit agreement, a Plan of Development is required to be filed yearly.

Approval of this agreement does not warrant or certify that the operator thereof and other holders of operating rights hold legal or equitable title to those rights in the subject leases which are committed hereto.
