APPLICATION

Mewbourne Oil Company applies for an order (i) approving a 1280 acre non standard project area in the Wolfcamp formation comprised of all of Sections 17 and 20 Township 21 South Range 25 East N M P M Eddy County New Mexico and (ii) approving an unorthodox gas well location and in support thereof states

1 Applicant is an interest owner in Sections 17 and 20 and has the right to drill a well thereon

2 Applicant proposes to drill its Rio Bravo 17/20 W2AP Fed Com Well No 1H to a depth sufficient to test the Wolfcamp formation Applicant seeks to dedicate Sections 17 and 20 to the well to form a non standard 1280 acre project area in the Wolfcamp formation (Wildcat Wolfcamp Gas Pool) The well is a horizontal well with a surface 195 feet from the north line and 1225 feet from the east line of Section 17 with a bottomhole location 330 feet from the south line and 660 feet from the east line of Section 20 The first take point will be 330 feet from the north line and 660 feet from the east line of Section 17 and the last take point will be 330 feet from the south line and 660 feet from the east line of Section 20 Both are unorthodox

3 Approval of the non standard project area and the unorthodox gas well location will prevent the drilling of unnecessary wells prevent waste and protect correlative rights

WHEREFORE applicant requests that after notice and hearing the Division enter its order

- A Approving a non standard project area in the Wolfcamp formation comprised of the Sections 17 and 20,
- B Approving an unorthodox gas well location for the Rio Bravo 17/20 W2AP Fed Com Well No 1H and
- C Granting such further relief as the Division deems necessary
