

- In assignment dated 3/1/2010 (808/884) Carl and Ruth Engwall Living Trust gave all interest (1 0% WI) to Steven Engwall (0 5%) and Larry Engwall (0 5%) The Primero JIB does not show an interest to Larry Engwall STO shows 1 0% WI to Engwall Living Trust subject to Title Requirement
- 2 In the Primero JIB James E Guy is credited with 2 0% WI and Bearing Service & Supply with 0 0% WI It also credits 2 0% WI in Milano #1 to Iris Camille Jackson Menefee and 2 0% WI to J T Jackson & Assoc In a Quit Claim Deed dated 10/6/2016 (1087/1034) J T Jackson et ux and J T Jackson & Associates conveyed all its interest to Camille Menefee (This document was recorded after the date of the STO) However the STO credits Bearing Service & Supply (James Guy& J T Jackson business) with 4 0%
- 3 Hammersmith Realty Inc never paid JIBs to NGX (original operator) and therefore NGX claimed the interest but Primero (successor operator) continued crediting the interest to Hammersmith Has Hammersmith paid JIBs to Primero?
- In and Assignment and Bill of Sale dated 10/28/2016 (1088/784) Pecos Petroleum Engineers Inc. conveyed the S2NE4 along with the Milano #1 & #2. However, it appears that the document contained sufficient catch all language to convey any and all interest in the NE4. However Primero JIB shows interest still in the name of Pecos Petroleum Engineers.
- 5 In the Primero JiB shows Permian Basin Investment Corp (PBIC) is shown with 2 5% WI however the STO show PBIC with 2 0% WI
- In the Primero JiB Scott Winn LLC is credited with 7 375% WI only in the Milano #2 and Scott Investment Corp with 7 875% WI in Milano #1 and 0 5% WI in the Milano #2 in the STO Scott Investment is credited with 17 125% WI in the Milano #1 (surface to base BS) and 13 625% WI in the remainder of the section from surface to base of BS
- 7 In the Primero JIB Southwest Petroleum Land Services LLC (SWPLS) is credited with 0 25% WI in the Milano #1 & #2 In the STO SWPLS is not credited with any interest
- The Primero JIB shows Team Fun Family Trust owning 0 5% WI in the Milano #1 & #2 however Team Fun does not appear in the STO (Could be Larry Engwall)
- 9 The Primero JIB shows David Wingo owning 1 875% WI in the Milano #1 & #2 Wing never paid NGX for JIBs Has Wingo paid Primero JIBs?
