Ladies and Gentlemen

Mewbourne Oil Company (Mewbourne) as Operator hereby proposes to form a 315 12 acre Working Interest Unit (WIU) covering the W/2 of the captioned Section 18 for oil and gas production. Apparently ConocoPhillips Company ("COPC") owns 100% interest in the SW/4 (157 63 net/gross acres) of the captioned Section 18. Accordingly COPC would own 50 022214% working interest in the proposed WIU (100% interest X 157 63 net acres / 315 12 gross acres = 50 022214% interest in the WIU).

Mewbourne as Operator hereby proposes to drill the captioned well at the above referenced surface location (SL) to the referenced bottom hole location (BHL). The proposed well will be drilled to a true vertical depth (TVD) of approximately 9 473 feet subsurface to evaluate the Wolfcamp formation for gas production. The proposed well will have a horizontal measured depth (MD) of approximately 14 029 feet. The W/2 of the captioned Section 18 will be dedicated to the well as the pooled proration unit and project area.


Regarding the above, enclosed for your further handling is our AFE dated January 6, 2017 for the captioned proposed well. In the event your firm elects to participate in the proposed well, please execute the enclosed AFE and return to me within thirty (30) days. Our Joint Operating Agreement to follow should you elect to participate.

As previously mentioned, Mewbourne has this well in our drilling schedule for the first week of March. It would be greatly appreciated if COPC can expedite this proposal.
