STATEMENT OF THE CASE

OXY seeks an order (1) creating a 320 acre non standard spacing and proration unit comprised of the S/2 N/2 of Section 9, and the S/2 N/2 of Section 10, Township 19 South Range 29 East, NMPM, Eddy County New Mexico, and (2) pooling all uncommitted interests in the Bone Spring formation underlying this acreage OXY proposes to dedicate the above-referenced spacing and proration unit as the project area for two proposed wells the proposed **Turkey Track 9-10 State No 22H Well** and the proposed **Turkey Track 9-10 State No 32H Well**, to

be simultaneously drilled and completed in the Bone Spring formation. These two stacked horizontal wells will be pad drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 8 to a standard bottom hole location in SE/4 NE/4 (Unit H) of Section 10. The completed interval for each well will remain within the 330 foot standard offset required by the Statewide Rules set forth in 19 15 15 NMAC.


