XTO seek an order from the Division (1) creating a non standard 320 acre spacing and proration unit comprised of the comprised of the W/2 E/2 of Section 8 and the W/2 E/2 of Section 17, Township 25 South, Range 29 East, NMPM Eddy County, New Mexico, and (2) pooling all mineral interests in the Bone Spring formation Willow Lake, Bone Spring, Southeast (Pool Code 96217) underlying this acreage Said non-standard unit will be the project area for

the proposed **Corral Canyon Federal Com No 15H Well**, which will be horizontally drilled from a surface location in the SW/4 SE/4 of Section 5 (Unit O) to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 17 The Division's district office has placed this acreage in the Willow Lake, Bone Spring Southeast (Pool Code 96217), which is subject to the general statewide rules The completed intervals for this well will remain within the 330-foot standard offset required by the Statewide Rules
