


1 Applicant is the operator of the proposed Salado Draw 10 W0PA Fed Com Well No 3H The well has a surface location in the NE/4NE/4 of adjoining Section 15 with a first take point 330 feet from the south line and 990 feet from the east line of Section 10 and a last take point 330 feet from the north line and 990 feet from the east line of Section 10

2 The Salado Draw 10 W0PA Fed Com Well No 3H will be drilled to a depth sufficient to test the Red Hills Wolfcamp Gas Pool (Pool Code 83600) Under Commission Order No R 3073, as amended a standard unit in the Red Hills Wolfcamp Gas Pool is 640 acres comprised of a governmental section, with wells to be located no closer than 660 feet to the outer boundary of a section All of Section 10 will be dedicated to the well

3 Approval of the unorthodox gas well location will prevent waste and protect correlative rights

WHEREFORE applicant requests that after notice and hearing the Division enter its order granting an unorthodox gas well location for the Salado Draw 10 W0PA Fed Com Well No 3H
