STATEMENT OF THE CASE

Applicant seeks a permit to inject up to 30,000 barrels per day of produced water into the Yates and Seven Rivers Formations at a depth interval from 2,915 feet to 3,060 feet below surface through its proposed Bobcat SWD Well No. 1, to be drilled 740 feet from the South line and 705 feet from the East line of Section 25, Township 25 South, Range 36 East, NMPM, in Lea County, New Mexico. Applicant proposes to drill this new well as a replacement for its existing Maralo Sholes B Well No. 2 (API No. 30-025-09806), located 660 feet from the South and East lines of the same section, township and range, which has been recently cited for violations due to defective construction and interference with a nearby producing gas well. Applicant proposes the well as a commercial operation for the purpose of disposal of produced water from multiple sources.

The Division opposes issuance of any permit that would authorize injection of produced water into the Yates and Seven Rivers Formations at, or in the vicinity of, the proposed location for the Bobcat SWD Well No. 1. The Division will show that the permit should be denied due to potential adverse effects to an identified Underground Source of Drinking Water (the Capitan Reef) under the Underground Injection Control Program and interference with oil and natural gas production from the Yates and Seven Rivers formations within the Jalmat; Tansill-Yates-Seven Rivers Pool (Pool code 33820).




