proposed **Airstrip 31-18S-35E RN State Com #132H Well**, which will be horizontally
drilled from a surface location in the SE/4 SW/4 (Unit N) to a standard bottom hole
location in the NE/4 NW/4 (Unit C) of Section 31 This project area is located within the




