**APPLICATION OF OXY USA WTP LIMITED PARTNERSHIP FOR A NON-  
STANDARD SPACING AND PRORATION UNIT AND COMPULSORY  
POOLING, EDDY COUNTY, NEW MEXICO.**

**ORDER OF THE DIVISION**

**BY THE DIVISION:**

This case came on for hearing at 8:15 a.m. on June 8, 2017, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 28<sup>th</sup> day of June, 2017, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

**FINDS THAT:**

(1) Due public notice has been given and the Division has jurisdiction of this case and the subject matter.

(2) OXY USA WTP Limited Partnership (the "Applicant") seeks approval of a 320-acre non-standard oil spacing and proration unit and project area (the "Unit") for oil and gas production from the Bone Spring formation, Turkey Track; Bone Spring Pool (Pool code 60660), comprising the S/2 N/2 of Section 9 and the S/2 N/2 of Section 10, both in Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico. Applicant further seeks an order pooling all uncommitted interests in the Unit for the Bone Spring formation.

(3) The Unit will be dedicated to Applicant's two "proposed wells" as follows. Both wells will be completed at standard locations within the Unit:

a. Turkey Track 9 10 State Well No. 22H (the "proposed well"; API No. 30-015-44122), a horizontal well to be drilled from a surface location 2150 feet from the North line and 395 feet from the East line (Unit H) of Section 8, Township 19 South, Range 29 East to a bottom-hole location 2254 feet from

the North line and 180 feet from the East line (Unit H) of Section 10, Township 19 South, Range 29 East, NMPM.

b. Turkey Track 9 10 State Well No. 32H (the "proposed well"; API No. 30-015-44109), a horizontal well to be drilled from a surface location 2180 feet from the North line and 395 feet from the East line (Unit H) of Section 8, Township 19 South, Range 29 East to a bottom-hole location 2254 feet from the North line and 180 feet from the East line (Unit H) of Section 10, Township 19 South, Range 29 East, NMPM.

(4) The proposed wells are within the Turkey Track; Bone Spring Pool and subject to Division Rule 19.15.15.9(A) NMAC, which provides for 330-foot setbacks from the unit boundaries and standard 40-acre units each comprising a governmental quarter-quarter section. The proposed Unit and project area consists of eight adjacent quarter-quarter sections oriented west to east.

(5) Applicant appeared through counsel and presented the following land and geologic evidence:

- (a) the Bone Spring formation in this area is suitable for development by horizontal drilling;
- (b) the proposed orientation of the horizontal wells from west to east is appropriate for the Unit;
- (c) the wells are being proposed as stacked horizontals to be completed simultaneously to achieve optimum productive capacity;
- (d) all quarter-quarter sections to be included in the Unit are expected to be productive in the Bone Spring formation, so that the Unit as requested will not impair correlative rights;
- (e) notice of the application and hearing in this case was provided to lessees or operators of surrounding tracts as affected parties of the proposed non-standard spacing unit;
- (f) notice by certified mail was provided to all uncommitted interest owners in the proposed Unit whose interests were evidenced by a conveyance instrument, either of record or known to Applicant when the Application was filed, and to heirs known to Applicant of deceased persons who appear as owners in such instruments, and whose identity and whereabouts could be ascertained by exercise of reasonable diligence; and

- (g) all affected parties were successfully contacted and provided with notice by certified mail, by newspaper, or by both certified mail and newspaper.

(6) The following parties made appearance in this case and were represented at the hearing through counsel: Thomas M. Beall, Fuel Products, Inc., V-F Petroleum Inc., Gahr Energy Company, Betty Read Young, Carolyn Read Beall, CBR Oil Properties, LLC, E.G.L. Resources, Inc. and Larry Stevens III, Successor Trustee of the Norman L. Stevens, Jr. Revocable Trust. These parties did not present evidence or oppose the application. Subsequent to the hearing, on June 23, 2017, the following parties made appearance: Snow Oil & Gas Inc. and the Estate of Nona Snow, deceased.

(7) No other party entered an appearance or otherwise opposed this application.

The Division concludes as follows:

(8) The proposed non-standard unit should be approved to enable Applicant to drill horizontal wells that will efficiently produce the reserves underlying the Unit, thereby preventing waste and protecting correlative rights.

(9) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.

(10) Applicant is owner or affiliate of an owner of an oil and gas working interest within the Unit. Applicant has the right to drill and proposes to drill the proposed wells to a common source of supply within the Unit at the proposed location.

(11) There are interest owners in the Unit that have not agreed to pool their interests.

(12) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense a just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.

(13) OXY USA WTP Limited Partnership should be designated the operator of the proposed wells and the Unit.

(14) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus an additional 200% thereof as a reasonable charge for the risk involved in drilling the proposed wells.

(15) Reasonable charges for supervision (combined fixed rates) for each well should be fixed at \$7000 per month while drilling and \$700 per month while producing, provided that these rates should be adjusted annually pursuant to the Overhead section of the COPAS form titled "*Accounting Procedure-Joint Operations*." The operator should be authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well(s), not more than what are reasonable, attributable to pooled working interest owners.

**IT IS THEREFORE ORDERED THAT:**

(1) Pursuant to the application of OXY USA WTP Limited Partnership, a 320-acre non-standard oil spacing and proration unit and project area (the "Unit") is hereby established for oil and gas production from the Bone Spring formation, Turkey Track, Bone Spring Pool (Pool code 60660), comprising the S/2 N/2 of Section 9 and the S/2 N/2 of Section 10, both in Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico.

(2) All uncommitted interests, whatever they may be, in the oil and gas in the Bone Spring formation underlying the Unit, are hereby pooled.

(3) The Unit shall be dedicated to Applicant's two "proposed wells" as follows. Both wells will be completed at standard locations within the Unit:

a. Turkey Track 9 10 State Well No. 22H (the "proposed well"; API No. 30-015-44122), a horizontal well to be drilled from a surface location 2150 feet from the North line and 395 feet from the East line (Unit H) of Section 8, Township 19 South, Range 29 East to a bottom-hole location 2254 feet from the North line and 180 feet from the East line (Unit H) of Section 10, Township 19 South, Range 29 East, NMPM.

b. Turkey Track 9 10 State Well No. 32H (the "proposed well"; API No. 30-015-44109), a horizontal well to be drilled from a surface location 2180 feet from the North line and 395 feet from the East line (Unit H) of Section 8, Township 19 South, Range 29 East to a bottom-hole location 2254 feet from the North line and 180 feet from the East line (Unit H) of Section 10, Township 19 South, Range 29 East, NMPM.

(4) The operator of the Unit shall commence drilling the proposed wells on or before June 30, 2018, and shall thereafter continue drilling the proposed wells with due diligence to test the Bone Spring formation.

(5) In the event the operator does not commence drilling the proposed wells on or before June 30, 2018, Ordering Paragraphs (1) and (2) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause demonstrated by satisfactory evidence.

(6) Should the proposed wells not be drilled and completed within 120 days after commencement thereof, then Ordering Paragraphs (1) and (2) shall be of no further effect, and the Unit and project area created by this order shall terminate, unless operator appears before the Division Director and obtains an extension of the time for completion of the proposed well for good cause shown by satisfactory evidence. If the proposed wells are not completed in all of the standard spacing units included in the proposed project area (or Unit), then the operator shall apply to the Division for an amendment to this order to contract the Unit so that it includes only those standard spacing units in which at least one well is completed.

(7) Upon final plugging and abandonment of the proposed wells and any other well drilled on the Unit pursuant to Division Rule 19.15.13.9 NMAC, the pooled Unit shall terminate, unless this Order has been amended to authorize further operations.

(8) OXY USA WTP Limited Partnership (OGRID 192463) is hereby designated the operator of the wells and the Unit.

(9) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping the proposed wells ("well costs").

(10) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."

(11) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed wells. If no objection to the actual well costs is received by the Division, and the Division has not objected, within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day period, the Division will determine reasonable well costs after public notice and hearing.

(12) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as

provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.

(13) Production from the proposed wells shall be separately metered before commingling unless the Division grants an exception for surface commingling providing for an allocation method suitable for leases with different ownership, pursuant to Rule 19.15.12.10.B(2) NMAC.

(14) The operator is hereby authorized to withhold the following costs and charges from production from each well:

- (a) The proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and
- (b) As a charge for the risk involved in drilling the well, 200% of the above costs.

(15) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.

(16) Reasonable charges for supervision (combined fixed rates) for each well shall be fixed at \$7000 per month while drilling and \$700 per month while producing, provided that these rates should be adjusted annually pursuant to the Overhead section of the COPAS form titled "*Accounting Procedure-Joint Operations*." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well(s), not more than what are reasonable, attributable to pooled working interest owners.

(17) Except as provided in Paragraphs (14) and (16) above, all proceeds from production from the proposed wells that are not disbursed for any reason shall be held for the account of the person or persons entitled thereto pursuant to the Oil and Gas Proceeds Payment Act (NMSA 1978 Sections 70-10-1 through 70-10-6, as amended). If not disbursed, such proceeds shall be turned over to the appropriate authority as and when required by the Uniform Unclaimed Property Act (NMSA 1978 Sections 7-8A-1 through 7-8A-31, as amended).

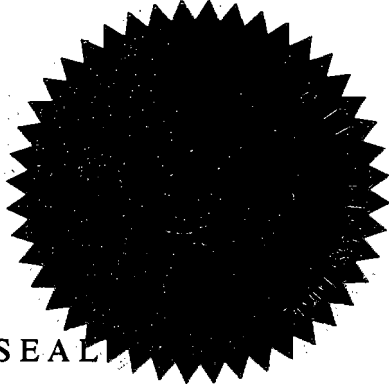
(18) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for allocating costs and charges under this Order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.

(19) Should all the parties to this compulsory pooling order reach voluntary agreement after entry of this order, this order shall thereafter be of no further effect.

(20) The operator of the wells and the Unit shall notify the Division in writing of the subsequent voluntary agreement of parties subject to the compulsory pooling provisions of this order.

(21) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
