





Gentlemen,

BC wishes to revise its previous Well Proposal to the following:

BC Operating, Inc. ("BC") as Operator, hereby proposes to form a 320.00 acre Working Interest Unit ("WIU") covering the East Half of Section 22, Township 24 South, Range 28 East, Eddy County, New Mexico. The proposed WIU shall supersede any existing Operating Agreements governing same lands.

In reference to the above, BC as Operator hereby proposes to drill the captioned Well at the referenced surface hole location ("SHL") to the referenced bottom hole location ("BHL"). The Well will be drilled to a true vertical depth ("TVD") of approximately 10,575 feet subsurface to evaluate the Wolfcamp formation for oil and gas production. The proposed well will have a horizontal measured depth ("MD") of approximately 14,935 feet. The E/2 of the E/2 of Section 22 will be dedicated to the well as the pooled proration unit and project area. Enclosed herewith, please find our Authority for Expenditure ("AFE") in the amount of \$5,947,660.00, which represents the total estimated cost to drill and complete the Well.

BC is proposing to drill the Well under the terms of a modified 1989 AAPL form of Operating Agreement which will be mailed under separate cover. The proposed Operating Agreement shall govern operations of the WIU described above, and will have the following general provisions:

- 100/300/300 Non-consenting penalty;
- \$7,000/\$700 Drilling and Producing rate;
- BC Operating, Inc. named as Operator;

If you do not wish to participate in the Well and WIU, BC would like to acquire your leasehold for the following general terms:

- \$2,000 per net mineral acre;
- Delivering full net revenue interest.







BC Operating, Inc., (OGRID No. 160825), Crown Oil Partners V, Crump Energy Partners, and Nadel and Gussman Permian, LLC ("Applicants"), through its undersigned attorneys, hereby file this application with the Oil Conservation Division pursuant to the provisions of N.M. Stat. Ann. § 70-2-17, for an order pooling all uncommitted interests in the Wolfcamp formation underlying the 320-acre, more or less, spacing and proration unit comprised of the E/2 of Section 22, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. In support of its application, Applicants state:

1. BC Operating, Inc. is a working interest owner in the E/2 of Section 22 and has the right to drill thereon.
2. Applicants propose to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Chicken Fry Federal Com No. 1H Well**, which will be drilled horizontally from the NE/4 NE/4 (Unit A) to a standard bottomhole location in the SE/4 SE/4 (Unit P) of Section 22.
3. Applicants have sought and been unable to obtain voluntary agreement for the development of these lands from all of the working interest owners in the proposed non-standard spacing unit.

4. The pooling of interests will avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

5. Pursuant to Rule 2 of the Special Rules set forth in Order No. R-14232, the proposed wellbore will be at an orthodox location because it will be no closer than 330 feet to the exterior boundary of the spacing unit.

6. In order to permit Applicants to obtain their just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this spacing unit should be pooled and BC Operating, Inc. should be designated operator of this proposed horizontal well and standard spacing unit.


