1. On August 2, 2017, the Hearing Examiners, during the hearing on this matter, requested that Applicant provide additional notice of the application and hearing. Applicant requested written direction regarding the scope of the additional notice requirement.

2. On August 11, 2017, Applicant received an email providing additional direction from the Hearing Examiners regarding the additional notice requirements.


