## STATEMENT OF THE CASE

Under these consolidated applications, OXY seeks orders creating three non-standard spacing and proration units and pooling all uncommitted interests in the Bone Spring formation underlying these units for the following acreage and proposed wells in Township 25 South, Range 29 East, NMPM, Eddy County, New Mexico:

- (1) Case No. 15869: a 318.88-acre non-standard spacing and proration unit comprised of the N/2 N/2 of Section 1 and the N/2 N/2 of Section 2. This spacing unit will be the project area for two proposed initial wells, to be drilled and completed simultaneously: the proposed **Corral Fly "02-01" State No. 21H Well** and the proposed **Corral Fly "02-01" State No. 22H Well**. These wells will be horizontally drilled from a surface location in the NW/4 NW/4 (Lot 4) of Section 2 to a standard bottom hole location in NE/4 NE/4 (Lot 1) of Section 1;
- (2) Case No. 15870: a 320-acre non-standard spacing and proration unit comprised of the S/2 N/2 of Section 1 and the S/2 N/2 of Section 2, to be dedicated to the proposed **Corral Fly "02-01" State No. 23H Well**, which will be horizontally drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 2 to a standard bottom hole location in SE/4 NE/4 (Unit H) of Section 1;
- (3) Case No. 15871: 320-acre non-standard spacing and proration unit comprised of the N/2 S/2 of Section 1 and the N/2 S/2 of Section 2. This spacing unit will be the project area for two proposed initial wells, to be drilled and completed simultaneously: the proposed **Corral Fly "02-01" State No. 24H Well** and the proposed **Corral Fly "02-01" State No. 25H Well**. These wells will be horizontally drilled from a surface location in the NW/4

SW/4 (Unit L) of Section 2 to a standard bottom hole location in NE/4 SE/4 (Unit I) of Section 1;

The completed interval for the proposed **Corral Fly "02-01" State No. 21 Well** and the proposed **Corral Fly "02-01" State No. 23H Well** will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC. The completed interval for the proposed **Corral Fly "02-01" State No. 22H Well** and the proposed **Corral Fly "02-01" State No. 25H Well** will be at unorthodox locations. OXY will apply administratively for approval of an unorthodox location for each of these two wells.


