APPLICANT'S STATEMENT OF CASE

Ameredev seeks an order (1) creating a 320-acre, more or less, spacing and proration unit comprised of the E/2 W/2 of Section 4 and the E/2 W/2 of Section 9, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico; and (2) pooling all uncommitted mineral interests in the Wolfcamp formation. This spacing unit will be the project area for the proposed **Firethorn Fed Com 26-36-04 No. 113H Well**, which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 33, Township 25 South, Range 36 East to a standard bottom

hole location in the SE/4 SW/4 (Unit N) of Section 9, Township 26 South, Range 36 East. The completed interval for this well will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.
