APPLICANT'S STATEMENT OF CASE

Matador seeks an order from the Division (1) creating a 152.78-acre non-standard spacing and proration unit comprised of the N/2 S/2 of Section 19, Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Bone Spring formation underlying this acreage. Matador proposes to dedicate the above-referenced spacing and proration unit as the project area for two proposed initial wells, to be drilled and completed simultaneously: the proposed **Marbob 19 State Com No. 123H Well** and the proposed **Marbob 19 State Com No. 133H Well**. These wells will be horizontally drilled from a surface location in

the NW/4 SW/4 (Lot 3) to a standard bottom hole location in NE/4 SE/4 (Unit I) of Section 19.
The completed interval for each well will remain within the 330-foot standard offset required by the Division's Statewide Rules.


