14540. Division Order R-14539 created a 160-acre spacing and proration unit consisting of the E/2 W/2 of Section 32, Township 18 South, Range 33 East, NMPM, in Lea County, New Mexico. This order further pooled the uncommitted interests in the Bone Spring Formation (Corbin; Bone Spring, South Pool (13160)) in this spacing and proration unit. Since the entry of Order R-14539, a working interest owner has failed to sign the operating agreement as previously anticipated. Accordingly, Chisholm seeks to pool the interest of the additional mineral interest owner pursuant to the terms of the existing pooling order.
