Applicant in the above-styled cause seeks an order from the Division for an order pooling all mineral interests in the Wolfcamp formation underlying the spacing and proration unit located within the W/2 of Section 18, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. Marathon plans to drill and complete the Gravel Grinder Fee 23-28-18 WXY 3H well, which is a horizontal well that will develop the Purple Sage Wolfcamp Gas Pool (Pool Code 98220) with in the proration unit along with two other wells: the Gravel Grinder Fee 23-28-18 WXY 10H and Gravel Grinder Fee 23-28-18 WA 5H. The perforations for these wells will be orthodox and comply with the special pool rules for the Purple Sage Wolfcamp Pool. Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon as operator of the well, and a 200% charge for risk involved in drilling said well.
