STATEMENT OF THE CASE

OXY seeks an order (1) creating a 640-acre non-standard spacing and proration unit comprised of the N/2 of Section 1 and the N/2 of Section 2, Township 25 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Wolfcamp formation underlying this acreage. OXY proposes to dedicate this non-standard spacing and proration unit as the project area for three proposed initial wells, to be drilled and simultaneously completed: The **Corral Fly "02-01" State No. 31H Well**, the **Corral Fly "02-01" State No. 32H Well**, and the **Corral Fly "02-01" State No. 33H Well**. The three proposed horizontal wells will be pad drilled from a surface location in the NW/4 NW/4 (Lot 4) of Section 2. The **Corral Fly "02-01" State No. 31H Well** will have a standard bottom hole location in the NE/4 NE/4 (Lot 4) of Section 1. The **Corral Fly "02-01" State No. 32H Well** and the **Corral Fly "02-01" State No. 33H Well** will have standard bottom hole locations in the SE/4 NE/4 (Unit H) of Section 1. The completed interval for the each well will remain within the 330-foot standard offset required by the Special Rule for the Purple Sage Wolfcamp Gas Pool (Pool Code 98220). Since these wells will be drilled and simultaneously completed, Oxy requests an extension of the 120-day period provided in the Division's standard pooling order to drill and complete a well.
