APPLICANT'S STATEMENT OF CASE

Percussion Petroleum Operating, LLC ("Percussion") (OGRID No. 371755) seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the E/2 E/2 of Section 27, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the N Seven Rivers; Glorieta-Yeso Pool (97565) underlying this acreage. Percussion proposes to dedicate the above-referenced spacing and proration unit as the project area

for its proposed **South Boyd Federal Com No. 13H Well,** which will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 34 to a non-standard bottom hole location in the NE/4 NE/4 (Unit A) of Section 27. The completed interval for this well is closer than 330 feet to the outer boundary of the project area than required by the statewide rules for oil wells. Percussion is seeking separate administrative approval for this unorthodox well location.
