Applicant BTA Oil Producers, LLC seeks an order (1) approving a 160.11-acre non-standard oil spacing and proration unit comprised of Lot 4 of the SW/4 NW/4, and W/2 SW/4

(the W/2 W/2) of Section 4, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation.
