This letter is to advise you that Black River Water Management Company, LLC ("Black River") has filed an administrative application with the New Mexico Oil Conservation Division sceking an order authorizing injection of produced water for disposal purposes through its proposed Malaga SWD No. 4 well (API No. 30-015-44514), with a surface location 1,489 feet from the North line and 490 feet from the West line (Unit E) of Section 11, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.
