APPLICANT'S STATEMENT OF CASE

Chisholm (OGRID No. 327137) seeks an order creating a 324.81-acre, more or less, spacing and proration unit comprised of the E/2 W/2 of Section 1 and the E/2 W/2 of Section 12, Township 19 South, Range 33 East, NMPM, Lea County, New Mexico, pooling all uncommitted interests in the Bone Spring formation underlying this acreage, and authorizing an unorthodox

location. Chisholm proposes to dedicate the above referenced spacing proration unit as the project area for its proposed **Buffalo 12-1 Fed Com 2BS No. 1H Well**, which will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 12 to a bottom hole location in the NE/4 NW/4 (Lot 3) of Section 1. The completed interval for this well will be closer to the northwestern and western boundaries of the proposed spacing and proration unit than allowed by the statewide rules.
