### **APPLICATION**

Tap Rock Resources, LLC ("Tap Rock") applies for an order to determine the validity of two infill well proposals submitted to it by Ameredev Operating, LLC ("Ameredev"), and in support thereof, states:

- 1. Under Division Order No. R-14662, Ameredev is the operator of the proposed Amen Corner State Com. 26 36 27 Well No. 111H, which has the W/2W/2 of Section 27 and the W/2NW/4 of Section 34, Township 26 South, Range 36 East, NMPM, dedicated to it ("Well No. 111H").
- 2. Tap Rock is a working interest owner in the horizontal spacing unit for Well No. 111H.
- 3. By letter dated June 26, 2018, attached hereto as Exhibit A, Ameredev gave Tap Rock an election, pursuant to Order No. R-14662 and Division regulations, to join in Well No. 111H.
- 4. In addition, the letter of June 26, 2018 also purported to give Tap Rock an election to join in the Amen Corner State Com. 26 36 27 Well Nos. 121H and 091H.
- 5. Division pooling regulations provide that when Division regulations or rules authorize infill wells within a spacing unit pooled by the Division under NMAC 1978 §70-2-17,

"either the operator or a pooled working interest owner, at any time after completion of the initial well provided in the pooling order, propose the drilling of an infill well." NMAC 19.15.13.9.

- 6. The recently enacted rules for horizontal wells, NMAC 19.15.16.15, specifically provide that subsequent wells in existing spacing units are subject to NMAC 19.15.13. See NMAC 19.15.16.15.B(9)(b)
- 7. Well No. 111H has not been commenced nor completed. Therefore, providing elections for the Amen Corner State Com. 26 36 27 Well Nos. 121H and 091H is not allowed by Division regulations.
- 8. Moreover, Ameredev has filed an application with the Division in Case No. 16342 to compulsory pool working interests in the Amen Corner State Com. 26 36 27 Well No. 091H. Not only is this contrary to the June 26, 2018 letter, the letter is not a proper well proposal under Division Order No. R-13165.
- 9. In addition, Tap Rock requests that, if it decides to join in the drilling of a well, that funds paid up front under the pooling statute and regulations, be held for only 90 days from the election, and then returned to the working interest owner if the well is not commenced by then. This is based on the unfairness of withholding large sums of money if the well is not promptly commenced.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

A. Holding that the elections for the Amen Corner State Com. 26 36 27 Well Nos.
 121H and 091H are impermissible and invalid at this time;

- B. Granting an emergency order providing that Tap Rock need not make an election on the Amen Corner State Com. 26 36 27 Well Nos. 121H and 091H pending a formal hearing and order on this application;
- C. Dismissing Case No. 16342, or at least continuing it until 30 days after a proper well proposal is sent to Tap Rock for the Amen Corner State Com. 26 36 27 Well No. 091H; and
- D. Granting such further relief as the Division deems proper.
