Manzano's application requests an order approving its Morrison San Andres State Exploratory Unit ("the Unit"), which is comprised of 4,371.42 acres, more or less, of State of New Mexico lands situated in Roosevelt County, described as follows:

The unitized interval is the San Andres formation, defined as the stratigraphic equivalent of the interval between 3,181 feet and 4,523 feet as depicted on the Laterolog dated September 12, 2014 for the Armstrong Energy Touch of Grey State #1 well (API No. 30-041-20960) located

1,839 feet from the south line and 417 feet from the west line in Section 15, Township 6 South, Range 34 East, N.M.P.M., in Roosevelt County.


