2. Enduring (OGRID No. 372286) is the designated operator under the Unit Agreement. The unitized interval includes all depths.

3. Enduring owns approximately 98 percent of the working interest in the Unit Area. Enduring is attempting to contact and reach agreement with the working interest owners in this acreage.

4. Applicant expects to receive preliminary approval of the Unit Agreement from the Bureau of Land Management, the Federal Indian Minerals Office, and the State Land Office.

5. The Unit Agreement, and the unitized operation and management of the Unit Area, are in the best interests of conservation, the prevention of waste, and the protection of correlative rights.

6. Notice of this Application will be provided to the affected parties and state and federal agencies.

7. Enduring will also cause notice of this application to be published in local newspapers of general circulation in San Juan County, New Mexico.

WHEREFORE, Enduring Resources, LLC requests that this Application be set for hearing before an Examiner of the Oil Conservation Division on September 6, 2018, and that after notice and hearing as required by law, the Division enter its order granting this Application.
