**MOTION FOR CONTINUANCE AND
OBJECTION TO PRESENTING CASE BY AFFIDAVIT**

Santo Operating, LLC ("Santo") moves the Division to continue the above-referenced case which is currently set for hearing on the November 1, 2018 docket until the December 6, 2018 docket. Additionally, Santo objects to presentation of this case by affidavit. In support of this Motion, Santo states,

1. NGL Water Solutions Permian, LLC ("NGL") has filed an application for an order approving disposal into the Devonian and Silurian formations through the Sidewinder SWD No. 1 Well.

2. Santo is the operator of a horizontal well in the adjacent Section 15 (Ocotillo Sunrise 15 WA AP Fee No. 002H (API No. 30-025-44294)). Said well is within the half-mile notice requirement of 19.15.26.8(A) NMAC.

3. Contrary to 19.15.26.8(A) NMAC, Santo did not receive notice of this application of hearing.

4. Santo objects to this application on the basis that the proposed injection well will interfere with its existing well and future development.

5. Santo further objects to the presentation of this case by affidavit because it will be prevented from cross-examining witnesses.


6. NGL's case should be continued until December 6, 2018, to allow the parties time to review and discuss potential solutions.


