Dear Sirs:

As per the attached letter dated January 11, 2017, the Bureau of Land Management concurs with ConocoPhillips Company, Operator of the Unit, that the San Juan 28-7 Unit 109M Dakota should have been deemed capable of producing in paying quantities in 1998. As such, 160.15 acres associated with Township 27 North, Range 7 West, Section 20: Lots 3, 4, and E/2SW/4 will be brought into the San Juan 28-7 Unit Dakota Participating Area (PA) with the 28th Expansion, effective November 1, 1998.

History:

With the 27th Expansion of the San Juan 28-7 Dakota PA effective 07/01/1975, T27N-R7W-Section 20: Lots 1, 2, E/2NW/4 (ada NW/4) was brought into the PA by Geologic Inference .

On 10/13/1998 the San Juan 28-7 Unit 109M well was completed to the Dakota formation. Due to Operator oversight, the well was not submitted for commercial determination. This left that portion of the well spacing, i.e., T27N-R7W-Section 20: Lots 3, 4, E/2SW/4 (ada SW/4), stranded outside of the Participating Area.

Subsequently, the San Juan 28-7 Unit 151E, completed 07/03/2008, was deemed capable of producing in paying quantities and brought into the 28th Expansion of the Dakota Participating Area, effective 08/01/2008.

ConocoPhillips Company became aware of the issue in August 2016 and determined that the San Juan 28-7 109M Dakota well was capable of producing in paying quantities when it was completed in 1998. The BLM concurred.

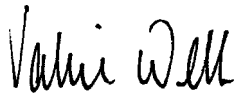

In 2016, the oversight was addressed, the well was deemed commercial and the stranded acreage is being brought into the PA by submission of this *REVISED* 28th Expansion of the PA, effective 11/01/1998.
