
Ladies and gentlemen:

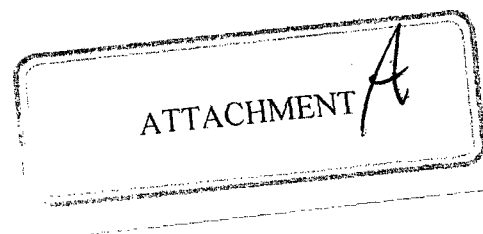



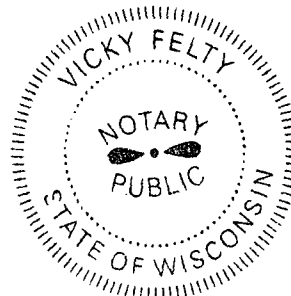

The unit will be dedicated to the Larry Wolfish 1&12-23S-27E RB Well No. 124H, a horizontal well with a surface location in the SE/4SE/4 of Section 36, Township 22 South, Range 27 East, N.M.P.M., a first take point in the NE/4NE/4 of Section 1, and a last take point in the SE/4SE/4 of Section 12. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
