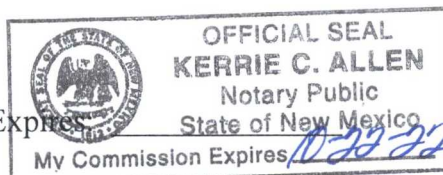


Ladies and gentlemen:


