To: Chisholm Energy Operating, LLC, Devon Energy Production Company, L.P., Freeport-McMoran Oil & Gas, and Wilson Oil Company, or your successors or assigns; Mewbourne Oil Company has filed an application with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests in the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2SE/4 of Section 17 and the W/2E/2 of Section 20, Township 21 South, Range 35 East, NMPM. The unit will be dedicated to the Steelhead 17/20 B2JO State Com. Well No. 1H, a horizontal well with a surface location in the SW/4NE/4 of Section 17, a first take point in the NW/4SE/4 of Section 17, and a final take point in the SW/4SE/4 of Section 20. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, February 7, 2019 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505.
