STATEMENT OF THE CASE

COG OPERATING, LLC (COG), seeks an order creating a 767.57-acre, more or less, horizontal spacing unit comprised of the E/2 of Section 20, the E/2 of Section 29, and the E/2 equivalent (N/2 NE/4, Lot 3, Lot 4) of Section 32, Township 26 South, Range 28 East, NMPM, Eddy County, New Mexico and compulsory pooling all uncommitted interests in the Wolfcamp formation, Purple Sage-Wolfcamp Gas Pool. COG seeks to dedicate the above referenced horizontal spacing unit to the following six initial wells to be drilled simultaneously:

- A. The proposed **Honey Graham State Com 801H Well**, the proposed **Honey Graham State Com 802H Well**, and the proposed **Honey Graham State Com 701H Well**, to be horizontally drilled from an orthodox surface location

in the NE/4NE/4 (Unit A) of Section 20 to an orthodox bottom hole location in Unit H of Section 32, and the

- B. The proposed **Honey Graham State Com 803H Well**, the proposed **Honey Graham State Com 804H Well**, and the proposed **Honey Graham State Com 702H Well**, to be horizontally drilled from an orthodox surface location in the NW/4NE/4 (Unit B) of Section 20 to an orthodox bottom hole location in Unit G of Section 32.

COG has negotiated in good faith with all parties it seeks to pool in this case.


