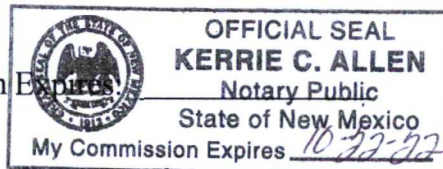


Ladies and gentlemen:




