#### **STATEMENT OF CASE**

Percussion has an interest in Lime Rock's proposed spacing units and objects to the application for pooling. Percussion has proposed a competing plan of development for the same acreage identified in Lime Rock's application, as summarized below.

In **Case No. 20232**, Percussion seeks an order pooling all uncommitted interests from the top of the Yeso formation to a depth of 3,000 feet in a proposed 200-acre horizontal spacing unit in the Red Lake Glorieta-Yeso Pool (51120) comprised of the SW/4 NW/4 of Section 18, Township 18 South, Range 27 East, and the S/2 N/2 of Section 13, Township 18 South, Range

26 East, NMPM, Eddy County, New Mexico, to be dedicated to the Toadies 18 No. 1H Well.

In Case No. 20371, an order pooling all uncommitted interests in the Yeso formation from a depth of 3,001 feet to the base of the Yeso formation in a proposed 200-acre horizontal spacing in the Red Lake Glorieta-Yeso Pool (51120) comprised of the SW/4 NW/4 of Section 18, Township 18 South, Range 27 East, and the S/2 N/2 of Section 13, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico, to be dedicated to the proposed **Toadies 18** No. 3H Well and Toadies 18 No. 4H Well.

In **Case No. 20227**, Percussion seeks an order pooling all uncommitted interests from the top of the Yeso formation to a depth of 3,000 feet in a proposed 160-acre horizontal spacing in the Red Lake Glorieta-Yeso Pool (51120) comprised of the N/2 S/2 of Section 13, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico, to be dedicated to the proposed **Cranberries "18" No. 1H Well**.

In **Case No. 20369**, Percussion seeks an order pooling all uncommitted interests in the Yeso formation from a depth of 3,001 feet to the base of the Yeso formation in a proposed 160-acre horizontal spacing unit in the Red Lake Glorieta-Yeso Pool (51120) comprised of the N/2 S/2 of Section 13, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico, to be dedicated to the proposed **Cranberries "18" No. 3H Well** and the **Cranberries "18" No. 4H Well**.

Percussion's Case Nos. 20232 and 20371 compete with Lime Rock's Case No. 20210 over development in the S/2 N/2 of Section 13 and the SW/4 NW/4 of Section 18. Percussion's Case Nos. 20332 and 20369 compete with Lime Rock's Case No. 20211 over development in the N/2 S/2 of Section 13. Percussion's competing pooling applications should be heard at the same time as Lime Rock applications. Percussion's applications should be approved, and Percussion, not Lime Rock, should be designated operator of the wells and spacing units for this acreage.
