**MEWBOURNE OIL COMPANY'S
PRE-HEARING STATEMENT**

Mewbourne Oil Company ("Mewbourne") submits its Pre-Hearing Statement pursuant to the rules of the Oil Conservation Division.

APPEARANCES

Mewbourne is the applicant in this case. Its business address is 500 West Texas Ave., Suite 1020, Midland, Texas 79701. Mewbourne is represented by the undersigned counsel.

STATEMENT OF THE CASE

Mewbourne's application seeks an order pooling all uncommitted mineral interests in the Wolfcamp formation in a 640-acre standard horizontal spacing unit comprised of the S/2 of Section 17 and the S/2 of Section 18, Township 22 South, Range 27 East in Eddy County, New Mexico.

Mewbourne proposes to dedicate the horizontal spacing unit to the Heavyweights 17/18 W0PM Fee #1H well, which will be horizontally drilled from a surface location in Unit P in Section 17 to a bottom hole location in Unit M in Section 18, Township 22 South, Range 27 East. The completed interval for the well will be orthodox.
