APPLICATION

Regeneration Energy Corp. ("Regeneration"), through its undersigned attorneys, files this application for an order approving the Blue Moon State Unit. In support of this application, Regeneration states:

1. The proposed Blue Moon State Unit area consists of the following 640 acres of State land situated in Eddy County ("Unit Area"):

TOWNSHIP 26 SOUTH, RANGE 27 EAST, NMPM

Section 16: All

2. Regeneration (OGRID No. 280240) is the designated operator under the proposed Unit Agreement and anticipated reaching agreement with all working interest owners in the Unit Area.

3. The unitized interval for the Blue Moon State Unit includes all depths.

4. Regeneration has met with the State Land Office and has received preliminary approval of the Unit Agreement.

5. Notice of this Application has been provided to the State Land Office, as the only notice party for the Unit Area.


6. The Unit Agreement, and the unitized operation and management of the Unit Area are in the best interests of conservation, the prevention of waste, and the protection of correlative rights.

7. Regeneration will also cause notice of this application to be published in local newspapers of general circulation in Eddy County, New Mexico.

WHEREFORE, Regeneration Energy Corp. requests that this Application be set for hearing before an Examiner of the Oil Conservation Division on July 11, 2019, and that after notice and hearing this Application be approved.
